customary meditation practice performed within the Sema, or worship ceremony, through which dervishes (also called semazens) aim to reach the source of all perfection, or kemal). Konya has the reputation of being one of the more religiously conservative metropolitan centers in Turkey and this place was the final home of Mevlana (Muslim poet, jurist, Islamic scholar, theologian, and Sufi mystic), whose tomb is in the city.

To sum up, my internship at Bıçak Law Firm in Ankara was an outstanding experience. I got a deep and inspiring insight in the work of the Turkish-based global law firm, but also beyond that Mr. Biçak as well as the other friendly and cooperative staff members took a lot of efforts to make my internship unforgettable.
